

#### Introduction

The five confirmed candidates for the FIFA Presidency were emailed on 26 November 2015 seeking their responses to an online survey comprising questions elicited online and from face-to-face meetings with football stakeholders, particularly fans who have no formal voice. Follow-up emails were sent, where relevant, on 6 December and 15 December 2015.

Responses were received from two candidates: Jerome Champagne and Shaikh Salman. They are reproduced in full below. We thank Mr Champagne and Shaikh Salman for their participation.

- Firstly, I'd want to meet all of the FIFA employees in the auditorium and outline to them the way forward. Some 400 people are working at FIFA in Zurich and they need and deserve encouragement. They need to know that FIFA will conduct its affairs differently in the future.
- Secondly, I'd meet with the Senior Management and get a report about all matters that are urgent and pending; we'd sit and discuss the best ways forward at this early stage (first day). I would ask them all to submit a written self-assessment and offer their views how the most important problems in their respective departments and divisions can be resolved short and medium term
- Thirdly, I would take numerous steps to commence with the restructuring of the organisation along the lines of my campaign platform

In my platform sent to the FAs on 23rd October, I proposed to set up an "advisory board" composed with persons from football and persons from "outside football" because I personally believe in oversight, separation of powers and in the capacity of "external" persons to bring in expertise and competences. Secondly, the expression "independent" is an expression which is not precise.

It is impossible to answer this question without falling into simplism. This question does not include the parameters of the potential results of the current investigations which should be based on facts and on the presumption of innocence. Secondly, there are other options than a "re-vote", for example, using the IOC jurisprudence to give the gold medal to the silver-medallist if the goldmedallist is convicted of cheating.

# SALMAN

Regardless of the outcomes of investigations? No. If serious wrongful conduct is proven by a court of law, we would of course revisit the issue.

# SALMAN

FIFA cannot be the UN, EU or Council of Europe, nor is it an international trade union organisation, nor can it dictate social and socio-political changes to any sovereign nation state. That is not FIFA's mission nor should it be. What FIFA must try and demand is that any and all persons who are directly or indirectly contributing to the infrastructure of a World Cup should be treated fairly, with respect and with dignity.

# CHAMPAGNE

The competence to vote for the WC belongs to the members of FIFA, the 209 national FAs. And I welcomed the reform brought in 2012 by the FIFA President to give back that decision to the FIFA Congress as it was the case between 1929 till 1966. On the other hand, involving "external expertise" to analyse bids is something not only very different but also necessary considering the complexity of the issues surrounding the organization of a WC.

# SALMAN

There is a proposal on the table to have the FIFA Congress vote for a World Cup host. I agree with that proposal and if it needs to be improved, I shall agree to improvements.

From what I remember, the Eckert Summary Report did not name any persons. If my recollection is accurate, the two whistleblowers identified themselves publicly. The Judge is not an employee of FIFA and the Ethics Committee acted independently from FIFA (see also the suspension of the FIFA President by the same Ethics Committee). Therefore, the FIFA President has no role to play in commenting about a verdict or statement issued by the Ethics Committee. Otherwise, FIFA would assume powers it had formally delegated to an independent outside body.

Regarding players: I am in favour of having a representation of players in ALL FAs as it is already the case in some to give players' unions the capacity to vote for the election of the presidents of the FA at national level giving them indirect voting rights to the FIFA presidency. At world level, the first step should be their participation to the FIFA Executive Committee and to the decisions. Clubs and leagues through pyramidal, inclusive and democratic world structures should be at the Executive Committee table as well. Regarding fans: the concept is good and correct but the complexity of its implementation is huge. Notably the mere definition of "what is a fan". Club membership however should be encouraged but this depends on club ownership.



# SALMAN

This deserves serious consideration and must be discussed in depth with all stakeholders. Presently, no such groups can do any of that at National Association level. Maybe a strong FA such as the English FA can set the pace?

Look at what happened for the analysis of some company-risk such as ENRON in the US or the financial situation of Greece before its entry in the Euro zone.

"Look at my track record when I was in FIFA (role in the creation of the Dispute Resolution Chamber in 2003, negotiation of the 2006 FIFA-FIFPRO agreement) and at my proposal for the future (collective bargaining agreement at world level, clearing house for traceability of transfers funds, presence and voting rights for FIFPro in FIFA executive committee, etc).

# SALMAN

"Professional players in my own country know me well and know my strengths and weaknesses to a certain extent: I don't think I need to convince them. Many in the Asian Confederation have a fair idea who I am and what I stand for. To try and 'convince' those who don't know me in 45 seconds would be a ludicrous and silly endeavour. If none of the persons present in the elevator suffer from claustrophobia, I would press the Stop Button and have a proper dialogue with the players."

# SALMAN

**Re. Q5**: I was not a Member of the Executive Committee in 2010 and have therefore not had access to any technical reports, the Bid Books, nor have I attended the presentations by the Bid Teams. I would have to study all of that documentation before I can arrive at a decision.

**Re. Q6**: Other: I was not a Member of the Executive Committee in 2010 and have therefore not had access to any technical reports, the Bid Books, nor have I attended the presentations by the Bid Teams. I would have to study all of that documentation before I can arrive at a decision.

**Re. Q27**: This completely depends on whom you ask and which part of the world is asked this question. Generally speaking, FIFA's reputation is badly damaged.

**Re. Q30**: Wherever large amounts of money are generated, there will often be weak and dishonest people who try to divert funds into their own pockets. Various law enforcement agencies and national bodies around the world have developed tools and early warning systems that help control corrupt practices. FIFA must learn from those and implement such tools under the guidance of outside experts. To eliminate opportunities is one promising policy, and to eliminate opportunities will imply the exercising of strict controls throughout the marketing and sales process in world football. FIFA will need expert help to come to grips with this societal illness. I have outlined certain tools and ways in my Campaign Platform.
